


- This test reflects «ego state profile» of a person – i.e.points out how much is each ego state present in real life, how is it active, how does the person manifest it
- This test cannot be diagnostical, 'cause there is no «good» ego state and no «ideal» ego state profile
- But it can be symptomatic, a reason to think about

- My first hypotheses that Critical Parent will strictly dominate over Adult in Risk Manager's ego-profile wasn't proven -
- But the logic of results is very close to that: interaction with Trader strongly activates Risk Manager's Critical Parent!


Peaks

- For each personal test, I took peaks those ego states that showed maximim activity (and, in addition – the second maximum value 'cause it is also interesting)
- ...and the most suppressed ego states (that showed minimum activity)
- And counted quantity of peaks in each ego state
- So, on those graphs there is shown total quantity of persons for whom Critical Parent (or Nurturing Parent, and so on) is dominating






- Not so obvious peaks maximum is in Adult, but Nurturing Parent and Natural Child are also active
- It sounds like quite balanced profile
- It is pleasing that Adult (in broad, personal life) dominates (I supposed it will be Critiizing Parent)
- Controlling (Critical) Parent is, surprizingly, suppressed (little maximums and many minimums)
- So does Adaptive Child Risk Managers do not seem to be very adaptive :-)




Obvious, dramatic changes:


- Controlling/Criticizing Parent rose MORE THAN 3 TIMES! (and vanished from suppressed position)
- Adult INCREASED ABOUT 2 TIMES! No suppression at all
- Not so good news: Nurturing Parent and Natural Child, who were very well manifested in 'common life' profile, here are the leaders of suppression!
- Adaptive Child became 1,5 times 'not so suppressed'



 Another view and way of measurement – mean/median value for activity (energy) of each ego state • mean and median are sufficiently close




Mean and median -

- Ego states that are responsible for freedom, pleasure, care for somebody are **dramatically suppressed**
- One the one side, that is not a surprise it is a business situation
- But this result is a point to think about in terms "what is a price for that?" (see also the next slide)
- And, on the other side: Natural Child is not only responsible for joy and carefreeness, it is also the source of creativity – this way we reduce our creative mind
- And Nurturing Parent who deals with slogan «how to help somebody do what he/she needs without restricting my own needs», who is the source of real partnership, is also fully out of energy – what partnership between Risk Manager and Trader is possible after that?

- You see that not only those two ego states the overall energy dramatically decreased
- But psychical energy, like physical, does not just expire nowhere – it can change form and location
- WHERE is this psychical energy located after that?
- ...Maybe, it flew to our inner psychological defenses mechanism? (remember – mature/immature defences)
- When psychological defenses are highly active, it is stressful situatuion, and in long term it can by psychologically dangerous
